This email is in response to your FOIA request relating to:

Please provide under the Freedom of Information Act all emails between Marion Gibson and any and all agents of Northpoint from January 2018 to present:

Please provide any and all emails exchange between Gibson and the Village Board and the Mayor Jenco for the same period.

Response: The emails/records responsive to your FOIA request are attached and contain certain redactions. The material redacted (unless otherwise noted in the specific emails below) are subject to the "deliberative process" exemption pursuant to 5 ILCS 140(1)(f) in that it contains preliminary drafts, notes, recommendations, memoranda and other records in which opinions are expressed or where policies and/or actions are formulated.

The email dated April 4, 2018 at 9:34am - the material redacted is exempt under section 7(1)(c) in that it contains "personal information" contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.

The email dated March 29, 2018 at 4:52pm - the material redacted is exempt under section 7(1)(m) in that it contains communication between a public body and an attorney representing the public body.
