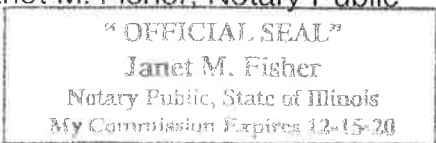

ADVERTISEMENT FOR BIDS  
VILLAGE OF ELWOOD, ILLINOIS

1. Time and Place of Opening Bids. Sealed proposals for the construction of the Water Supply Well No. 8 Pumping Equipment for the Village of Elwood, Will County, Illinois, will be received at the Village Hall at 401 E. Mississippi Avenue, Elwood, Illinois 60421 until 10:00 A.M., April 15, 2019, and at that time will be publicly opened and unit price total read aloud.
2. Description of Work. The proposed construction consists of 1,000 gpm submersible pumping equipment, well televising, pitless unit, demolition of concrete vault and foundation, testing, and other miscellaneous items of work.
3. Information for Bidders. All pertinent documents may be examined at the Village Hall at 401 E. Mississippi Avenue, Elwood, Illinois 60421. Copies of the Bidding Documents may be obtained from the Engineers, Baxter & Woodman, Inc., upon a non-refundable payment of \$50 per set. Documents can be purchased only at the Crystal Lake office.  
Not less than the prevailing rate of wages as determined by the Department of Labor or determined by the court on review shall be paid to all laborers, workmen and mechanics performing work under this contract.  
The Village of Elwood is exempt from the Illinois State, municipal or county Retailers Occupation Tax, Service Occupation Tax, Use Tax, and Service Use Tax as described in Illinois Compiled Statute Chapter 35. Bid prices shall not include the cost of such taxes.  
All Bids must be accompanied by a Bidder's bond, certified check, bank cashier's check or bank draft payable to the Village of Elwood for ten percent (10%) of the total amount of the Bid as provided in the Bidder Instructions.
4. Rejection of Bids. The Board of Trustees reserves the right to reject any or all Bids and to waive technicalities. Unless the Bids are rejected for good cause, award of contract shall be made to the lowest responsible and responsive Bidder.
