**ORDINANCE NO. 1129**

**AN ORDINANCE OF THE VILLAGE OF ELWOOD AMENDING THE CODE OF ORDINANCES WITH RESPECT TO TRUCK ROUTE DESIGNATION**

WHEREAS, the Village has previously designated truck routes within the Village; and,  
WHEREAS, the Illinois Department of Transportation has amended its method of classifying roads; and

WHEREAS, the Illinois Vehicle Code has been amended to reflect the changes made by IDOT;

WHEREAS, it is in the best interest of the Village to amend the Village Code of Ordinances to reclassify the roads previously referred to “Truck Routes.”

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ELWOOD, WILL COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME-RULE AND OTHER AUTHORITY, AS FOLLOWS:

**SECTION 1. AMENDMENT**

That 73.11 of the Village of Elwood Code of Ordinances be and the same is hereby deleted and the following inserted in its place:

73.11 Designated Class II Roads

The following Village streets are designated as “Class II Designated Streets”:

**CLASS II DESIGNATED ROADS**

Walter Strawn Drive	Baseline Road/ (EIP)	Illinois Route 53	1.74 miles
Centerpoint Drive	Mississippi Avenue	Walter Strawn Drive	0.56 miles
Mississippi Avenue	Baseline Road/ (EIP)	Diagonal Road	1.14 miles
Diagonal Road	Mississippi Avenue	1,850 linear feet north	0.35 miles
Brandon Road	Noel Road	Village Limits	0.51 miles
Noel Road	Brandon Road	Approximately 5491 linear feet west to 21100 W. Noel Road	1.04 miles

All streets not specifically designated as Class II hereunder are “Non-Designated” streets or highways.

**SECTION 2.**

That 70.002 of the Village of Elwood Code of Ordinances is hereby amended to include the following definition:

Truck Route. A local street or highway classified as a Class II Designated Road. The terms Truck Route and Class II Designated Road are to be used interchangeably.

**SECTION 3. REPEALER**

All Ordinances and parts of Ordinances of the Village of Elwood in conflict with any of the provisions of this Ordinance, to the extent of such inconsistency and no further, are hereby repealed upon the effective date hereof.

**SECTION 4. SEVERABILITY**

Should any section, subsection or other provision of this Ordinance for any reason be held invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not effect the validity of the Ordinance as a whole or any part not declared invalid.

**SECTION 5. EFFECTIVE DATE**


This Ordinance shall be in full force and effect after its passage and approval and publication in pamphlet form.

Resolution Establishing a Class II or Prohibited Truck Route

WHEREAS, the State of Illinois by its General Assembly has enacted the Illinois Vehicle Code, and WHEREAS, 625 ILCS 5/1-126.1 provides that local authorities may designate Class II or Prohibited Truck Route highways within their jurisdiction...

WHEREAS, Village of Elwood is desirous of designating truck routes under their jurisdiction as follows:

NOW THEREFORE, BE IT RESOLVED, that the portion of roadways as listed below will be designated as shown.

BE IT FURTHER RESOLVED, that Village of Elwood in accordance with 625 ILCS 5/15-116 which requires local public agencies to provide the Department of Transportation with reference contact names and telephone numbers provides contact information as follows:

Contact information table with columns: Name, Title, Phone Number. Includes Julie Friebele (Village Administrator) and Larry Lohmar (Public Works Director).

BE IT FURTHER RESOLVED, that the Clerk is hereby directed to transmit three (3) certified originals of this resolution to the district office of the Department of Transportation along with a location map indicating the roadways being classified.
